## Continuing Pandemic Effect

Phi Sigma Tau, as is the case for many honor societies, is still in recovery mode from the pandemic. Before the pandemic, we were averaging about 1225 new members each year, but that has dropped to an average of about 840 for the past four years. Our low year was 2019-2020 when we inducted only 598 members; so far as I know, that was the only year that our expenses exceeded income. During the four years, many chapters did not function, and though chapters that had been active were not marked inactive during the first three pandemic years, many of them have not become active again; currently, we have about half of our chapters that are marked inactive, though we hope they will become to function again. We inducted 929 new members this last school year.

Demands on faculty continue to be enormous as teachers attempt to adapt to the need to teach in person and online at the same time. This leaves little time for chapter advisors to devote time to the society; no advisors are ever paid for their work, though there is the fringe benefit of being able to devote time to the best students. Students are also impacted by these demands on professors' time as well as the demands made on students. However, Covid is less of a problem than it once was; at least in some areas, case numbers are far below the height of the pandemic, and fewer (though too many) people are dying from the disease. May matters continue to improve!

One positive sign of improvement is an increase of petitions for new chapters. Phi Sigma Tau chartered chapters in seven schools during the 2022-2023 school year. Those were at Eastern Connecticut State University, Simmons University in Boston, Mississippi State University, Missouri State University, Saint Louis University, Syracuse University, and The University of Texas at Dallas. In the first three pandemic years, we chartered only two new chapters. Our task now is to try to encourage the inactive chapters to become active again.

Among other activities, in March the members participated in the AU philosophy department's annual conference. The topic was "Language and Value." The students read a few of the papers in advance, formulated their own questions, and raised those questions to open a few of the q&a sessions at the conference. They did an excellent job!

On March 2nd, they watched a screening of the film “First Reformed.” The screening was followed by a discussion of the film, led by Dr. John Dick. On March 21st, at 7pm, in the Lyceum (HC 6088), they met informally to discuss a paper on Spinoza by one of their own members, Matthew Grier.

April in the chapter was extremely full. Here is the message Dr. Gorodeisky sent them:

This Thursday, March 30th, at 7pm, in Coffee Cat (124 Tichenor Ave., behind the Hound), the club will host a roundtable on “Value.” After our 6 panelists (3 faculty members and 3 Phil club students) finish their short presentation, the stage will be open for a discussion with the audience. Be there and bring a friend!

On Thursday, April 4th, at 4pm, at Pebble Hill, the club will host a meeting with the Civil Rights Activist, Dr. Bernard Lafayette. We will meet earlier in the week, on Tuesday, April 4th, at 3:30, to read the first chapter of Dr. Lafayette’s memoir in preparation for our conversation with him. Looking forward to seeing you in both meetings!

Dr. Gorodeisky continues: Even after the meeting in Lafayette, April in the club will continue to be very busy: First, the philosophy department has two philosophy guests from Uppsala University, Sweden, during April: Dr. Nick Wiltsher and Dr. Irene Marin Martinez. They will both either meet the club for informal conversations about their research or present a film to the club. Exact dates and times TBA!

On April 14th, Dr. Andrew Huddleston (Warwick, UK) will be a guest of the philosophy club, the philosophy department, and the JCM museum. Between 12-1 of that day, he will host an informal conversation about his book manuscript on art and religion to the philosophy club and the general museum audience in the JCM museum galleries. We will be able to give you an excuse if you need to miss a class for this meeting. At 3pm on the same date, Dr. Huddleston will present another chapter of his manuscript to the AUPS and the philosophy club at the JCM museum auditorium. We will meet earlier that week to discuss one of Dr. Huddleston’s chapters of this book manuscript.

On April 28-29, the department will host another conference, this time on aesthetics. The format will be very similar to the format of the “Language and Value” conference: it will also take place approximately between 9 and 5 in Pebble Hill, with a reception at Well Red on Friday night (April 28th). The philosophy club will again meet earlier that week to discuss some of the papers in preparation for the club’s students to raise their own questions to the speakers at the beginning of the respective discussions.
